If you require an initial consultation, all consultations are at a separate cost from the IV. Straightforward new patient IVs and follow-up IVs typically do not need a consultation. A certified RN administers all IVs in our comfortable IV room.

We advise you to hydrate well before any IV (i.e., drink plenty of water). Hydrating will help to ensure that your IV is successful. Sometimes, your veins do not permit us to administer an IV successfully if you are not well hydrated.

Please note that a \$40 administration fee applies if the IV content can be safely saved/kept for you to have done at a later date. If the IV content cannot be safely saved/kept, then the total/full cost of the unsuccessful IV will apply.

You may schedule a Myers' Cocktail or Glutathione IV directly with the RN without a consultation. However, if you wish to have a 30-minute consultation regarding an IV, you may schedule it before the IV is administered on the same day.

Customized IV therapy requires an initial consultation. The initial consultation is scheduled for 30 minutes with Emily Stadick, F.N.P., to discuss and set up a treatment plan. Once a treatment plan has been discussed, your customized IV will be ordered through the compounding pharmacy. Customized IVs require pre-payment.

Follow-up consultations are not required unless a new customized IV therapy is requested or you have any complex questions that the RN cannot answer.

A deposit fee is due at the time of scheduling your initial appointment. The deposit fee will apply towards your total amount due at the time of service and is refundable if you cancel the appointment with two (2) business days' notice. The deposit fee is forfeited if you cancel the initial appointment without two (2) business days' notice, and the appointment will not be rescheduled.

If an established patient misses two (2) appointments (i.e., no communication to our office regarding the need to cancel the appointment), then dismissal from the practice will occur.
