* The initial Detoxification consultation without a Heavy Metal Urine Test kit requires you to send us your Heavy Metal Urine test results and basic lab work before we schedule your appointment.

^{*}All five (5) prepaid IVs must be used within 90 days from the date of purchase.

We advise you to please hydrate well before any IV (i.e., drink plenty of water). Hydrating before an IV will help to ensure that your IV is successful. Sometimes your veins do not permit us to administer an IV if you are not well hydrated successfully.

Please note that a \$40 administration fee applies if the IV content is savable for you to have done at a later date. If the IV content is unsavable, then the total/full cost of the unsuccessful IV will apply.

An initial Detoxification consultation is required. The duration of the consultation appointment is one (1) hour with Dr. Laurie Blanscet, D.O. This consultation is prepaid when you pick up your test kits.

If you are scheduling a consultation without the test kits, a deposit fee is required when scheduling your initial consultation. The deposit fee will apply towards your total amount due at the time of service and is refundable if you cancel with a two (2) business day notice for the initial consultation without the test kit.

^{*}The initial Detoxification consultation, which includes the Heavy Metal Urine Test kit, must be pre-paid when you pick up the test at our office. The test kit consists of the DMSA capsules and a pre and post-DMSA urine test kit.

The treatment plan may be oral Chelation medication (through the compounding pharmacy) or IV Chelation (administered at our office by a certified RN).

All treatment cost for Detoxification is at a separate cost from the initial consultation.

The Heavy Metal Urine test results are required for us to schedule your appointment. If you have had a Heavy Metal Urine test within the last six (6) months, please obtain copies of your results and send them to our office. Otherwise, we will have you do a Heavy Metal Urine test before scheduling your appointment. We will schedule your initial consultation once the results are in (it takes approximately three (3) weeks).

Payment for the Heavy Metal Urine test kits is due at the time of pick up at our office.
