Ozone Therapy Consultation:

Ozone Therapy Consultation: \$200

The consultation does not include the cost of treatment.

If you have had Ozone Therapy before or feel that you do not need a consultation, you may talk with one of your RN's to evaluate if it is appropriate to skip the consultation.

Ozone Therapy Treatment:

MAH (IV Blood Ozone): \$200—per session

IV Blood Ozone with Meyer's Cocktail: \$300

IV Blood Ozone with Meyer's Cocktail and Glutathione: \$375

5 Pre-paid IV Blood Ozone: \$900

5 Pre-paid IV Blood Ozone with Meyer's Cocktail: \$1450

5 Pre-paid IV Blood Ozone with Meyer's Cocktail and Glutathione: \$1725

- All 5 Pre-paid must be used within 90 days from date of purchase.

Rectal Ozone: \$50

5 Pre-paid rectal Ozone: \$200

- Must be used within 60 days from date of purchase and bring back bag for the 5 treatments

Vaginal Ozone: \$50

5 Pre-paid Vaginal Ozone: \$200

- Must be used within 90 days from date of purchase

Limb Bag Ozone: \$50—per site

IV Blood Ozone Treatment with Rapid EDTA Chelation: \$300

An initial Ozone Therapy consultation is required. It is scheduled for 30-minutes with Dr. Laurie Blanscet, D.O. or Sharon Ackerman, P.A.-C, for evaluation and discussion of a treatment plan. There are different treatment options of Ozone Therapy that our office offers. The Ozone Therapy treatment depends on your specific needs.

The cost of the Ozone Therapy treatment is at a separate cost from the initial Ozone Therapy Consultation.

IV Blood Ozone Therapy treatments are administered through an IV by a certified RN at our office in our comfortable IV room.

Rectal Ozone Therapy is administered through a sealed bag that can be taken home but needs to be used within 30-minutes from inflation.

Vaginal Ozone Therapy is done in the office.

Here at An Optimal You, we value every patient. Cancellations with short notice and missed appointments adversely affects our ability to accommodate patients. Therefore, An Optimal You has a cancellation policy for all initial and follow up appointments.

A cancellation fee will apply if appointments are not cancelled with at least a 2 business days' notice (a business day is Monday-Friday, non-holidays).

In order to avoid a cancellation fee, you must contact our office 2 business days before your appointment time to reschedule. (Of course, we do understand significant emergencies and encourage you to contact our office immediately if an unforeseen event occurs and we will evaluate your situation on an individual basis)

For optimal treatment, communication is necessary, therefore any initial consultations that are missed (i.e. no contact with our office) will not be re-scheduled. If an established patient misses two appointments (i.e. no communication to our office regarding the need to cancel the appointment), that patient will be discharged from our practice.

We do our best to accommodate your needs and we ask that you respect other patients by giving our office adequate notice when needing to reschedule an appointment.
